

TO FIX THE NUMBER, PROPORTION PER CATEGORY AND ALLOWANCES OF REGIONAL COUNCILLORS



The Parliament deliberated and adopted, the President of the Republic hereby enacts the law set out below:

## CHAPTER I GENERAL PROVISIONS

<u>SECTION 1</u>: This law fixes the number, proportion per category and allowances of regional councillors.

SECTION 2: (1) Regional councillors shall be:

- delegates of divisions elected by indirect universal suffrage;
- representatives of traditional rulers elected by their peers.
- (2) The regional council shall reflect:
- the various sociological components of the region;
- gender aspects.

## CHAPTER II NUMBER AND PROPORTION PER CATEGORY OF REGIONAL COUNCILLORS

**SECTION 3:** The number of regional councillors per region shall be fixed at 90 (ninety).

<u>SECTION 4</u>: In each region, the proportion per category of regional councillors shall be as follows:

- 70 regional councillors for the category of delegates of divisions;
- 20 regional councillors for the category of representatives of traditional rulers.

<u>SECTION 5</u>: (1) Each division shall constitute an electoral constituency for the election of regional councillors.

- (2) However, some electoral constituencies may be grouped or specially warded by decree of the President of the Republic in view of their particularities.
- (3) The regional council shall comprise at least one councillor from each sub-division, for the category of delegates of divisions.

<u>SECTION 6</u>:A decree of the President of the Republic shall fix the number of regional councillors for each category per division or, where applicable, per constituency ensuing from grouping or special warding.

## CHAPTER III ALLOWANCES OF REGIONAL COUNCILLORS

SECTION 7: (1) Regional councillors shall be entitled to a session allowance.

(2) During their tenure, regional councillors shall be reimbursed expenses incurred in respect of sessions.

SECTION 8: Regional councillors may be entitled to mission allowances outside of sessions.

<u>SECTION 9</u>: The amounts, terms and conditions of payment of the allowances and mission allowances referred to in Sections 7 and 8 above shall be fixed by decree of the President of the Republic.

## CHAPTER IV FINAL PROVISION

<u>SECTION 10:</u> This law shall be registered, published according to the procedure of urgency and inserted in the Official Gazette in English and French./-
